

LIVELIHOODS

Watershed Programmes

Odisha Tribal Empowerment & Livelihoods Programme (OTELP)

The program with LAVS as FNGO is currently in its withdrawal phase after due completion of its Probation and Implementation Phase. The program is being implemented in 10 micro watersheds that include 52 program villages covering 1789 Households in 4 GPs of Pottangi Block in Koraput district.

The programme adopts a public private and community partnership approach in implementation of the programme. In this PPCP mode, community has taken the lead role in planning, executing, monitoring and evaluating the program, whereas, as the state government provides the technical assistance and support and the NGO plays the role of a facilitator in mobilizing community and empowering them. The program is implemented through various grass root institutions such as SHG, UG, VDC, CIGs etc.

The program stresses up-to the benefits of all the families within the geographical boundary of one micro watershed. The association of all adult members within the micro watersheds is the Village Development Association (VDA) and is registered under Society Registration Act XXI of 1860. Village Development Committee (VDC) is the Executive Body responsible for managing day to day activities of VDA.

The program focus is to build the capacity of the primary stakeholders in order to ensure community participation in the development process. As the success of the program entirely depends upon the knowledge, skill, abilities of the members of the community and their ownership, community mobilization and skill up gradation framework has been formulated to ensure inclusion of all section of community.

b. Beneficiaries Skill Development:

Livelihood of the poor is primarily dependent on their skill base. The program has adopted the strategy for adding-in new skills and upgrading the existing skills of the primary stakeholders. Skill-based trainings, exposures, demonstrations etc. have been designed based on the activity plan proposed by the communities under AWPB. Various training programmes conducted during 2012-13 are furnished here-as-under:

IFAD Top Up Assistance:

Support to Ultra Poor/Vulnerable Families:



The top-up financing is continuing to support the on-going development interventions of OTELP. Under IFAD TOP UP Assistance vulnerable HHs are supported, guided & encouraged to have change-in livelihood for a living with dignity in community. Rice-Huller, Grocery, Tailoring Unit, Cycle/Motor-Cycle Repairing-Centre, Vegetable-Vending & low-cost Housing Support were provided to 74 House Holds through concern VDCs.

Creation & Development of Irrigation Infrastructure:

To ensure proper utilization of water source and address the issue of "Water-Scarcity in Agriculture" and domestic level efforts have been made. In the operational villages; 3 nos. of DBI, 6 nos. of small lift irrigation, 1 hidam under development to be utilized by community. 10 Water-lifting devices were provided to selected beneficiaries to use the same in cultivation activities.

Focussed Livelihoods intervention:

- Focus livelihood intervention gave opportunity to 51 HHs beneficiaries supported for Goat-Rearing Unit.
- 20 no. of beneficiaries are supported for "Commercial Vegetable Cultivation" (with raised-bed and dripirrigation).
- 8 nos. of Unemployed Youths are supported under economic activities

Improvement of Habitation and Sanitation



• As habitation improvement is a matter of concern in tribal pocket, similar initiatives have been taken to habituate the people for a healthy life. Biomass cook stoves are provided to 125 HHs. Toilet & Bath-Rooms are also constructed for the same family to maintain cleanliness and hygiene.

Investment in DIF

This is an additional and flexible funding to address to area of demand as expressed by communities through the participatory process during the course of program implementation and also to supplement those components/ interventions of the program yielding very good results. It also enables the communities to implement activities which are not accommodated in other program components. Accordingly under program components, provisions has been made for targeting the traditionally excluded households e.g. single women headed households, landless, destitute, physically challenged and those who are unable to be a part of the SHG or other income generating activities.

The activities under DIF are broadly divided into four categories such as;

- Supplementary Funding to other Programme components
- Experimenting and / or up scaling innovative activities for livelihoods
- Promotion of low-cost, time & labor saving technologies for reduction of drudgery
- Support to the Vulnerable and Destitute Households living in the operational Program Villages

Supplementary-Funding to other Program Component:

- 4 nos. of multipurpose Community-Centre have been constructed in 4 Program Villages to be used by community for conducting meeting, festival & to store agricultural produce with safety measure.
- 8 nos. of Irrigation Wells have been dug at appropriate places to assist the farmers to cultivate their land during all season.
- 1 Diversion-based Irrigation Pproject (pipe) has been constructed at Ghatguda which will provide water for domestic as well as cultivation purpose. About 60 farmers of Ghatguda, Maksapondei & Pondei will be benefited through this DBI.
- 4 nos. of new Check-Dams have been constructed at Maliguda, Baduguda & Bailopadu to provide water to ensure proper utilization of water.
- Piped-Water Supply Project for domestic use and irrigation is under fast construction in 9 Operational Villages.

Experimenting and/or Up-Scaling Innovative Activities for Livelihoods:

- In order to ensure safety storage of Seed Grains Storage Bins (Silo) have been provided to 300 beneficiaries in operational program villages.
- Small-Scale Processing Unit i.e. Rice-Hullers have been provided to 6 beneficiaries.
- Agricultural Pump-Sets are provided to 10 nos. of Beneficiaries for Water-lifting during Cultivation.

Promotion of low cost, time and labor saving technologies for reduction of Drudgery

• Improved Cook Stoves have been provided to 130 beneficiaries & 2 nos. for usage at institutional level

Support to the Vulnerable and Destitute Households:

• 20 nos. of identified Vulnerable families have been ensured extensive livelihood supports through "Skill-based Economic Activities" towards enabling their livelihood sustainability.

<u>Self-Help Groups:</u>

122 SHGs are not only functioning for thrift and credit have been oriented & developed through various training & exposures to play the role that of a catalyst at community-level for empowerment. Ten

numbers of VDCs level SHGs Federations are actively functioning to ensure right & entitlement. During the year 8 no. of SHGs have availed Rs. 2, 65,000/- loan from the respective federation and undertaken cultivation of ginger, ragi, chilly, potato and onion. All VDC-level federation members have formed a Block-level Apex Body titled "Maa Gangeswari Mahila Mandal" to manage SHGs and to address issues related to right & entitlements of Women. The sense of unity & integrity



expressed by 1000 women members in a "Get-to -Gather" held on 23.03.2015 at Pukali is a ray of hope to mark the initiation of a new-era in the life of marginalized sections. Apex Body is in-process to emerged as a Registered Body and function independently.

Agriculture & Horticulture Development:

20 nos. of beneficiaries have been supported for "Vegetable Cultivation through Drip-Irrigation mechanism". The farmers are encouraged to cultivate in up season for more yielding. Improved Cultivation of Cauliflower, Cabbage, Chilli & Beans are undertaken by selected beneficiaries to demonstrate and inspire other beneficiaries to do so. Paddy like "SAHABHAGI" for medium up land demonstrated in 2.5 Ac covering 20 Beneficiaries and the result is all encouraging to continue the same within agreed period. Monsoon potato cultivated in 13 Acres of Ralegada & Pukali G.P.s covering 50 beneficiaries. Ginger up scaling has been taken ahead in 10 Ha. covering 50 farmers.

Livestock & Aquaculture Development:

Pisciculture is undertaken in 20 farm ponds in OTELP villages covering 6 SHGs and 14 individuals involved in taking benefits from these initiatives.

Convergence:

The Organization has mobilized funds from MGNREGS & developed SCT in 2 ha. & CCT in 3000 RMT in 3 villages of Ralegada & Pukali G.P. Through these initiatives 1505 mandays has been created with beneficiaries ensured local job employability.

WDF-NABARD Watershed Programme:

The Project operates in two-Phases, viz (i) Capacity Building Phase (CBP) for a period of 12 months and (ii) Full Implementation Phase (FIP) with the participation of Village Watershed Committee (VWC) and Programme Facilitating Agency (PFA) with financial supports in-form of grant only from NABARD in addition to labour contribution of 16% or Shramdan from the community. The government assistance of Rs 6000/ha. as per DPAP norm @ 70% for physical treatments, 25% for administrative cost, 7.5% for livelihoods of landless and 12.5% for Community Organizations & Training have also been utilized in addition to WDF. The major activities are Human Resource Development, Soil & Land Management, water management after Catchment Treatment, Afforestation, Pasture Development, Agricultural Development, Livestock Management and Rural Energy Management.

The Deomali Watershed is located in Pottangi Block of Koraput district in the state of Odisha. Having a treatable area of 681.83 ha, it is situated by the left side of the National highway at a distance of 30 Km from Pottangi Block. Deomali Peak is situated at a distance of 60 km from Koraput with an elevation o 1,672 meter. It is the highest peak in Odisha.and the tallest in the whole of the Eastern Ghats. Deomali is dotted with streams and deep valleys, and dense forest. The project areas are surrounded by hillocks and forest those contribute to the internal drainage system of the Project area. Mainly uplands are undulated and uneven with small stone patches. The average slope is 3-5 percent and the general drainage pattern is dendritic. The district is composed with undulating tracts of high ridges and low valleys. Different types of land like Hills & Hill-Slope, foothills, upland, medium and low land are found in Pottangi block.

After completion of Capacity Building Phase (CBP) of the "Watershed Program" supported by NABARD, LAVS has successfully graduated to the Final Implementation Phase (FIP) of Watershed Program in the same Micro Watershed Area in Kotia GP of Pottangi Block in Koraput district since the year 2012. This watershed approach to developmental intervention aims at alleviating habitat and inhabitant impoverishment through a holistic approach of conservation & sustainable exploration of natural & human resources.

The Turia (Kandhamali) & Taupadar (Deomali) Watersheds being facilitated by LAVS are located in Pottangi Block of Koraput district in the state of Odisha. It is situated by the left side of the National highway at a distance of 30 Km from Pottangi Block and having a treatable area of 1203.89 ha in Turia

Key Agronomical Interventions & Outcomes:

The change in "Land-Use-Pattern" by the identified community people was noticed as a significant Outcome due to some key activities undertaken in the Watershed area that mostly included Field-Bunding and land development measures. The main activities are summarised here-as-under:

- Summer Ploughing for better Weed-Management & Pulverizing the soil for aeration
- Crop Diversification and more emphasis on Line-Sowing
- Farmers encouraged for Organic Farming: Organic Manure, Vermi-compost, Vermi wash Azotobacter, Azospirillium, Rhizobium, Azolla etc. and low-cost Organic Pesticides
- Farmers encouraged for high yielding and Improved Varieties
- Intercropping, Mixed Cropping, Stripe Cropping adopted by farmers
- More emphasis given on cash crops like Maize, Onion, Groundnut and Vegetables
- Introduction of new crops like Ginger, Yam, Cassava, Mustard and Sunflower
- Documentation of ITKs and refinement for sustainable agriculture
- Seed and Variety Replacement
- Provide need-based Training
- Collaboration & Convergence of services from Line Departments

Promotion of Farmer's Club

As part of an attempt to promote village-level Institutions to work on the principles of "Development through Credit" by the community level Farmers, LAVS have credibly partnered with NABARD in the implementation of Farmers Club Program in Pottangi Block for the last four years. During this period LAVS has created as many as 13 Farmers Clubs in Pottangi block of Koraput district as per details follow:

Skill Development

In order to develop skill of rural youths, LAVS has established two "Skill Development Training





Centers" in Koraput and Jharsuguda districts respectively. Trades selected for training of youths are Agriculture, Horticulture, Mobile Repairing,

Motor-Winding, Dress Designing and Computer Courses. Training is imparted in batches, with 20-25 trainees as Batch-Strength. During the period under report a total number of 154 Youths received training in different trades.

WOMEN EMPOWERMENT

Mahila Kisan Sashatikaran Pariyojana (MKSP)

Odisha is amongst the most poorest of India's major states, despite of its' rich endowment of natural resources, and coastline. Odisha has the highest proportion of poor persons in its population relative to all other states/UTs in India. However, there have been positive developments in recent years, and poverty rates in Odisha have declined from 57.2% to 37% between 2004 and 2009-10 (Odisha Economic Survey, 2012-13). Despite of this improvement, poverty rates in Odisha are about 7% more than the National average. Non-Monetary Indicators of Poverty too confirm the "Low-Welfare Status of Odia households". Eighty four percent of Odisha's 41.9 million



population is rural, and a vast majority of the poor live in rural areas.

Koraput district of Odisha is mostly backward. The livelihoods of the rural people are mainly agriculture, collection of NTFP from forests and animal husbandry. Agriculture is under-developed due to series of bio-physical constraints. The crop productivity is comparatively low and the farmers have less access to irrigation. Shifting cultivation practiced at quick successions has caused serious biological and environmental complications. The women population of the district is apparently underprivileged. Keeping this in view, the MKSP has been prepared for implementation in Pottangi and Semiliguda Blocks of Koraput district. The project aims to cover 3000 women households in 10 Gram Panchayats of two Blocks in the district. With the geographical area of 8807 sq km the district has human population of 13, 76,934 as per census 2011. The rate of literacy is only 49.87% as against the State literacy of 73.45%. The density of population in the district is 156 which is much less than the State density of 269 per sq km. The district has 14 CD Blocks, 226 Gram Panchayats and 2243 villages. The sex ratio of the district is 1031 per 1000 males, whereas it is 1044 in rural areas. This means that more number of women live in rural areas. The literacy rate in the district is still less in rural areas with 43.27% (Census 2011). The ST population of the district is 49.62% of the total whereas it is 13.04% in case of SC (Census 2001). It means the ST and SC population of the district is 62.66% as against the State average of 38.66%. The minority population of the district is hardly 6%.

Promotion of WSHGs in LWE District:

The National Bank for Agriculture and Rural Development (NABARD) assisted LAVS to empower women in Left Wing Extremism affected districts, with informed presence and involvement of LAVS in implementing development programmes in Koraput. The project aimed at Financial Inclusion, establishing linkages and creating an enabling environment for ideal financial relations with formal financing institutions. RURAL DEVELOPMENT

Rural Connectivity



LAVS is assigned the task of providing consultancy in the capacity of Project Implementation Consultant (PIC) to the ADB assisted PMGSY Roads under Rural Connectivity Investment Programme (RCIP) being implemented in the state of Odisha. The activity is undertaken by the Rural Works Department, GoO. The assignment involves preparation of "Community Participation Framework, Environmental Code of Practices, preparation of Road Maintenance Report, Road Safety Report" inline with the mandate of the programme. This also includes thematic training of the Engineers associated with the programme.

Involvement of LAVS covers 25 districts in the state. LAVS successfully accomplished the following spell-out mandates:

The above mentioned works are distributed through different tranches of assignment such as Tranche I/ II/ III under RRS II and RRS III Investment Programme.

Gender issues have taken a prime space while forming policies and implementing the programmes as per prescribed paraphernalia by the state Govt. The implementation of the PMGSY is being carried out through the Dept. of Rural Works -Govt. of Odisha. The Dept. is all sensitive towards complying to minimum protocols of ADB-prescribed Gender Action-Plan.



The Gender Action Plan has been incorporated to promote Gender Equity & Equality, minimize social discrepancies based on gender discrimination of earning opportunities irrespective of gender differences.



Gender Action Plan also ensures Gender Equity and Social Inclusion, thus strengthening government efforts for an inclusive growth. Concentration of male participation in activities other than in the household tasks is loosened through implementation of the Gender Action Plan and a part of the concentration is passed to the female sex. The GAP not only ensures inclusion of women in labour-intensive tasks, but also ensures gender parity in activities involving high skill, technologies and managerial abilities. Under this context, PMGSY implemention in Odisha as per instructions of the state

government, the contractors are instructed by the PIUs to meet the standards as suggested by the GAP.

Clean Energy (Solar Power)

Electricity, now-a-days, is considered as the most sustainable source of energy, which has become a bare necessity for any layman. But the targeted tribal communities in the MKSP Area are still far away from availing this basic amenity. Considering this aspect LAVS entered into an agreement with TERI (The Energy and Resource Institute) to provide lighting and electricity for other usage in operational villages in Koraput district from an alternative source, the Solar energy. Accordingly, 50 nos. of villages were covered under the programme benefitting 1000 households in lighting their homes, making their lifestyle more simpler and more intersting. Similar initiatives have been promoted with the support of OTLEP & NABARD in another 45 Villages in 4 GPs of Pottangi Block.

HEALTH

Evidence-based Media Advocacy Initiatives on Child Stunting and Nutrition issues in Odisha

UNICEF awarded a project to LAVS to study and find the role of media in connection with addressing issues relating to "Malnutrition and Stunting Child in the state of Odisha". The activities involved piloting on the degree of involvement of both "Print & Electronic Media" in making the Readers/ Viewers on Issues relating to Breast-Feeding, Nutritional Food, Infant Morbidity & Mortality, Maternal Mortality etc. The stakeholders included the Newspapers, Telecast / Electronic Media, Civil Societies etc. The rationale of the project was derived from its core objective of targeting media for orientation & sensitization thereafter facilitating a process by which "*Media acts as a Tool*" for dissemination of appropriate information. The project is a dynamic mix of knowledge management, dissemination and advocacy targeting media.

- 1. Collection of Data in respect of contents published (articles/ write ups/ interviews etc.) relating to theme
- 2. Collection of Data in respect of contents telecasted (articles/ Write-Ups/ interviews etc.) relating to theme

- 4. Interviews with Media Personnel
- 5. Conducting Zone level Seminars for sharing & dissemination
- 6. Conducting State Level Seminar for dissemination
- 7. Recommendations for filling the identified Gaps

Advocacy on Reproductive Health Rights

LAVS has been; in association with Orissa Voluntary Health Association, Bhubaneswar implementing a project to ensure Reproductive Health Rights in 60 villages in 5 CD-Blocks of Jharsuguda district under the sponsorship of DFID-PACS Media advocacy, Social Audit, Loka Sambad, Empowerment of Adolescents, particularly the girls etc. are important components of the project implementation.

National Level Panchayat Verification under RGPSA

The Ministry of Panchayatiraj, Govt. of India has awarded the National Field Verification of Panchayats for incentivization under Rajiv Gandhi Panchayat Sashaktikaran Abhiyan (RGPSA) in 3 states; Odisha, Assam and Manipur. 


