## ACTIVITY PANORAMA-2016-17

### SECURING LIVELIHOODS AND EMPOWERING TRIBAL COMMUNITIES (OTELP)

LAVS is implementing the OTELP project in Pottangi Block of Koraput District as the facilitating NGO (FNGO) with the support of SC & ST Development Department, Government of Odisha. It is an external aided programme funded by IFAD, DFID and WFP. The programme was implemented by the ST & SC Development Department. ***The programme aims to empower tribal community, ensure food security of poor tribal households with providing livelihood opportunities which are sustainably improved through promoting more efficient equitable self managed and sustainable exploitation of the Natural Resources at their disposal and through off farm/non-farm enterprise development.*** The main target group of the project comprised of communities in villages where the majority 68% of the inhabitants are below the poverty line; 75% of target population belongs to ST category & 15% to SC category; STs and SCs together constitute 90% of target group.

#### Programme Components:

**Capacity Building:** Focus of the programme include mobilize communities, empower them through awareness creation on tribal rights, gender and equity issues, natural resource management and programme planning; assist them, through micro-planning exercises, in the prioritization of their development needs and in the formulation and implementation of

development proposals and build/strengthen appropriate community institutions. This also aims to strengthen the capacity of the support agencies that will assist them as facilitators.

**Livelihood Enhancement support:** (i) land and water management; (ii) participatory forest management to regenerate degraded forest land and to develop NTFP processing and marketing enterprises; (iii) improvements in agricultural productivity; (iv) improvements in animal husbandry; (v) improved access to rural financial services through the promotion of self-help savings and credit groups and linking them with formal financing institutions to augment their capital base; and (vi) development of community infrastructure to fill critical gaps in the provision of key rural infrastructure and to provide for necessary economic and social infrastructure.

**Forest Rights:** Under the forest rights activities, the programme aims to support the operationalization of the government's existing Policy Initiatives in relation to tribals' access to land and forest products.

**Development Initiatives Fund:** This fund makes provision of an additional funding conclusion to provide the flexibility to address in areas of demand as expressed by communities and also to supplement those components/interventions of the programme yielding very good results.

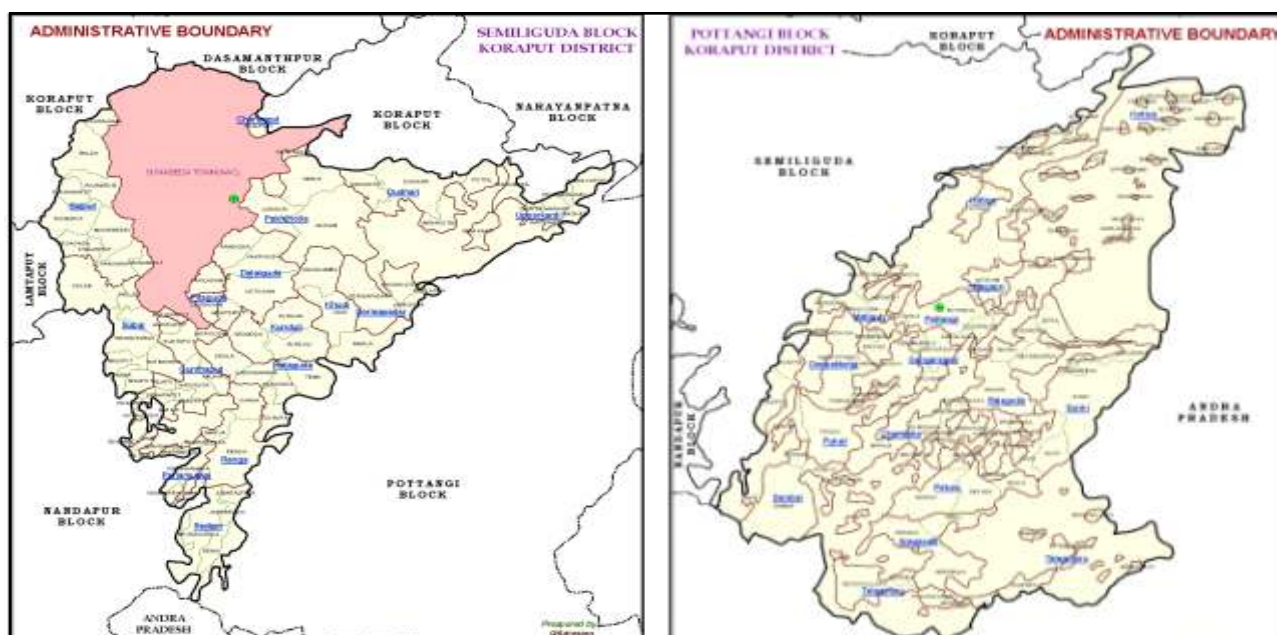
## TRANSFORMING LIVES OF WOMEN FARMERS (MKSP-MoRD)

The project is being implemented in Potangi and Semiliguda Blocks of Koraput District, Odisha with the technical guidance and funding support of State Rural Livelihoods Mission (SRLM) and National Rural Livelihoods Mission (NRLM). The project aims to contribute for improved health and nutritional security, reduction of drudgery of women agriculture workforce and empowerment of women farmers. It has organized 3000 women farmers through a network of community based

platforms like SHGs, Producer Groups, Federations and Marketing Societies. Besides professional staff, a dedicated team of CRPs and PRPs is providing handholding and process level facilitation in project implementation. The project emphasizes Focus on the poor, Focus on women and Adherence to protocols on Sustainable Agriculture. The greatest advantage of the project lies in its attempt to develop and tap social capital, especially women, in deepening development outreach and effectiveness.

## Best Practices Documented

### Common Facility Centre (CFC) :



Five (5) Common Facility Centre (CFCs) have been established in 5 different locations of the program villages of both Pottangi and Semiliguda Blocks of Koraput district. These CFCs functions as Custom Hiring Centres/Tool Banks with the overriding objective to promote farm mechanization and reduce drudgeries of women farmers through use of women friendly implements and technologies. The farmers take advantage of such benefits from the Common Facility Centres (CFC) on hiring and rotational basis against payment of nominal user fees which are utilized for repair and maintenance on self sustainable mode.

### Farmers Field School (FFS) :

The FFS approach is an innovative, participatory and interactive learning approach that emphasizes problem solving and discovery based learning. FFS aims to build farmers' capacity to analyze their production systems, identify problems, test possible solutions and eventually encourage the participants to adopt practices most suitable to their farming systems and use technologies. FFS is usually a time bound activity (generally one agricultural production cycle) involving a group (20-30) of farmers. Two (2) FFSs have been developed under MKSP in the program village. Farmers at large and women farmers in particular have immensely benefited from such exposure and hands-on training.



### Social Audit:

Social Audit has been integrated in the MKSP programme implementation strategy to build transparency and accountability. It has promoted informed participation of women farmers and their institutions. Social audit committees have been formed taking members from the community and engaged in the review processes on regular basis.

10 best practices under the project have been documented highlighting the good initiatives and success of Mahila Kisans supported by the project. These are:-

- ♦ Indigenous agricultural practices: a successful model from Chorimaliput village
- ♦ Cooperative farming: an exemplary form of group based farming culture by producer's group, Malipungar
- ♦ Organic agriculture: successful crop production without use of chemicals
- ♦ Crop diversification: varied range of crop production with appropriate seasonality management, a practice evolved out of the process.
- ♦ System of Crop Intensification (SCI): an example of application of SCI beyond rice cultivation.
- ♦ Nutritional kitchen garden in convergence with watershed funds
- ♦ Adoption of new farm technologies and equipment by tribal women farmers for efficiency, productivity and drudgery reduction.
- ♦ Fair price for agricultural produces: increased market accessibility and price bargaining

## PROMOTING COMMUNITY ADAPTABILITY TO CLIMATE CHANGE (NABARD-KfW)

**LAVS** with support of NABARD-KfW (Germany) partnership is implementing watershed development programme in Taupadar and Thuria Watersheds of Pottangi Block, Koraput to protect rain-fed regions from further degradation and to improve natural resource based livelihoods. Climate change adaptation is the key component of this initiative. Investments in improvement, stabilization, conservation of natural resources mainly soils is made to minimize the risk emanating from climate change and to increase the productivity as well as income of communities living in watersheds.

The purpose of the interventions under the programme is to reduce vulnerability due to climate change of small & marginal farmers in selected watersheds through the stabilization, enhancement and sustainable use of soil and water resources. The project operates with the goal to improve adaptive capacity of the communities in watersheds so that their vulnerability to climate change is reduced on a sustainable basis. The project is taken up for a period of three years starting with the current year. Some of the achievements made under the project are as follows:-

## ACCELERATING RURAL DEVELOPMENT THROUGH CONNECTIVITY (PIC-PMGSY)

Rural Road connectivity is a key component of rural development, since it promotes access to economic and social services, thereby generating increased agricultural productivity, non-agriculture employment which in turn expands rural growth opportunities and real income addressing poverty and destitution among masses. Rural roads are rightly called development multipliers accelerating growth, income and inclusion. Pradhan Mantri Gram Sadak Yojana (PMGSY) aims at providing connectivity by means of



properly laid all-weather surfaced roads (with necessary culverts and cross drainage structures) to all unconnected habitations.

**LAVS** has been engaged as the Project Implementation Consultant (PIC) by OSRRA to provide support to State Implementing Agency in implementation of ADB's requirements of Social Safeguards, Environmental Safeguards, Road Safety and Road Maintenance. The task also requires conduct of due diligence and monitoring of a part of earlier batches of projects sanctioned by ADB in the State. **LAVS** has deployed a team of social, engineering and environment experts to carry out the assigned tasks. Technical support is provided by Technical Support Group appointed by National Rural Roads Authority (NRRDA) for the purpose.

**Social and Resettlement Safeguard Implementation Activities include :**

- i. Assisted PIU in organizing the transect walk for documenting the social features and profile along the alignment for each sub project proposal.
- ii. Prepared the record of community participation through the Field visits to the project affected communities to ensure that CPF requirements have generally met. Ensured the involvement of the affected people and community groups in assessing the same.

Determined the requirement of regulatory clearances (environment/forest/archaeological) to be sought from Govt. of India or State Govt. and provide advisory services to PIU on environmental aspect including implementation and monitoring of the identified provisions of the ECOP by the contractor.

- vi. Prepared Due Diligence report of project tranches and implementation of earlier batches of RRSII-IP

## **Road Safety**

### ***At the DPR preparation stage***

- a. Conducted RSA (Road Safety Audit) including mandatory field visits, jointly with PIU and 60 DPR's (in each annual batch) for roads with at least one road from each district from each batch and prepare concise RSA report listing road safety issues and proposed measures to mitigate / eliminate road safety issues.
- b. Conducted follow up desk review of final DPRs (Detailed Project Reports) to check how the issues identified by 60 RSAs in Task A are addressed and report to PIUs.

Based on the RSAs under the batch, prepared the summary of RSA issues and suggestions for the batch and submit to PIU/ OSRRA for review and action on remaining, not audited DPRs as appropriate, as this will address issues identified on road safety audited roads but perceived to be common on other roads under the batch.

### ***During construction***

Conducted RSIs (Road Safety Inspections) jointly with PIUs on randomly selected roads (at least 60 roads in each RRSIII-IP tranche) with at least one road from each district under construction and prepare concise RSI reports listing road safety issues and proposed measures to mitigate/eliminate road safety issues, especially for vulnerable road users.
- b. Reported to PIUs on road safety issues identified during construction and follow up on road safety issues/lapses as appropriate.
- c. As per direction of the OSRRA, conducted independent analysis of severe road accidents occurred on the RRS-III-IP roads under construction, if any, and recommend specific road safety countermeasures for review and endorsement by PIU/OSRRA.

### ***At the post-construction stage***

- a. Conducted RSIs on randomly selected roads (at least 10 roads in each RRSIII-IP batch) within three month after completion of civil works, and prepare concise RSI reports listing road safety issues and proposed measures to mitigate/eliminate road safety issues.
- b. Conducted RSIs on randomly selected roads completed under RRSII-IP and RRSIII-IP (at least 30 roads a year, in addition to immediate post-construction RSIs described under A above and prepare concise RSI reports listing road safety issues and proposed measures to mitigate/eliminate road safety issues.
- c. Prepared Quarterly Road Safety Monitoring reports for the roads inspected in concise matrix format, including status of the roads where RSI is conducted, issues observed, and measures proposed for implementation.
- d. As per direction of the OSRRA, conducted independent analysis of severe road accidents occurred on the RRS-II-IP and RRS-III-IP roads over the period of RRSIII-IP implementation, if any, and recommend specific road safety countermeasures for review and endorsement by PIU/OSRRA.

### ***Road Safety Training***

- a. Conducted on-the-job training of PIUs on conducting RSA and RSI during the joint road safety audits and inspections conducted together with PIU staff

- b. Provided dedicated training to PIUs on conducting RSA and RSI and implementing engineering road safety counter measures.

- Submitted Maintenance Inspection Reports for each road inspected; and
- Prepared Annual Maintenance Audit Reports for the inspected roads in the state

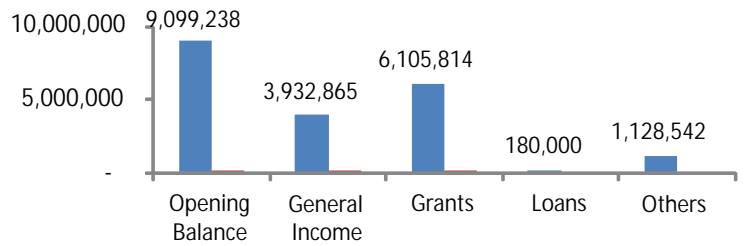

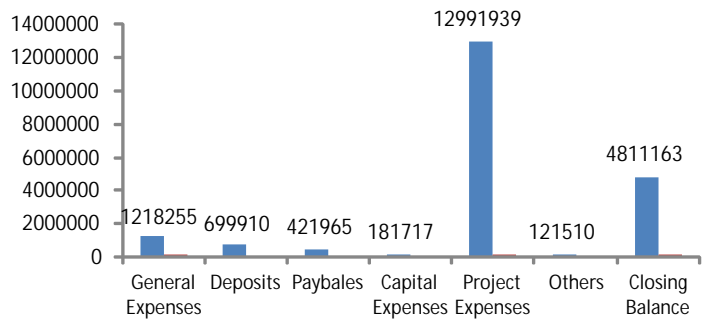

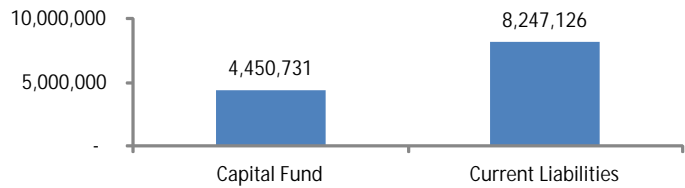
