

ACTIVITIES DURING 2019-20

EMPOWERING GRASSROOTS:

As part of our mandate and focus area, Empowering Grassroots aimed at handholding, training and enabling community based organizations to maximize their impact on the ground, strengthening the bottom of the socio-economic pyramid.

Under 'Empowering Grassroots" initiatives, CBOs are trained on vital issues relevant to development initiatives and interventions like scalability, sustainability, communication, resource mobilization, management and governance. Handholding meetings, and interface learning sessions are held round the year



to help the CBOs effectively function and resolve day to day challenges. Empowering Crassroots is not only an effort to strengthen the bottom of the socio-economic pyramid of the society but also an attempt to bring transparency and accountability in the development process at the very grass root level.

Approach:

- Scalability Scale up on ground projects qualitatively as well as quantitatively and reach out to maximum number of people with better services and benefits
- Sustainability Bring stability in ground operations, engage and encourage the community for active participation and achieve self sustainability.
- Communication- Communicate goals, vision, work and impact effectively to community stakeholders.
- Resource Mobilization-Develop a steady resource pool for day to day implementation and look for alternative sources from local community to leading corporate
- Governance- Imbibing a deep sense of accountability leading to proper fund utilization and transparency in all processes.

Our Achievements:

- 568 Women Collectives (SHGs) have been promoted and strengthened
- 18 Farmers Club are promoted and are in place
- 2 FPOs registered under Company Act are engaged in aggregation, value addition and marketing of agri produce with membership base of 220 member farmers in Koraput
- 68 Producer Groups (PGs) as collectives have been promoted and trained on production, value addition and marketing.
- 2 women federations are actively engaged in capacity building and leadership development.
- 35 inter face and hand holding meetings were organized where an attempt was made to understand the ground challenges and issues faced by the grass root organizations.

- A dedicated team from LAVS conducted monitoring visits, in-house training, discussions, community stakeholders meetings and mobilizations sessions to enhance the efficiency and output of community initiatives and encourage local support and action.
- 12 watershed associations formed

MANAGING NATURAL RESOURCES & CLIMATE RESILIENT AGRICULTURE:

Development of Micro-Watersheds is one of the important programs of LAVS over the years and our technical competency and social mobilization in this participatory program is our key strength. Proofing of watershed from climate change challenges and building community resilience has been an additional focus area being looked into under this program for strengthening, stabilizing and sustainable utilization of natural resources within the watershed area.

Strategy/Approach:

The strategy adopted and implemented by LAVS to de-risk agriculture consists of the following initiatives.

Agro-Advisory Service:

Timely information on likely weather forecasts together with response advisories help farmers take preventive measures and reduce crop losses. LAVS has established **one Automated Weather Stations** (AWSs) in watershed area Based on this information and weather forecasts provided by the IMD, LAVS provides crop and local specific weather based advisories to farmers.

Organic Formulations:

Farmers are advised and guided in the preparation of organic formulations like *Amrutpani, Handikhat*, neem ark etc that help in restoring degraded lands, increasing soil health, controlling pests and disease infestation, reducing input costs and improving yields. Trainings and demonstrations in the preparation and use of organic

formulations activities like Amrutpani, Handikhat, neem ark, were carried out.

System of Crop Intensification:

The SCI technique adopts a fourpronged approach which involves field preparation and management, crop spacing, systematic application of locally prepared organic and biological inputs and micro-nutrient foliar sprays. The SCI technique helps to increase the growth of crops grains, pods, fruit and leafy vegetables. It is the integration of



a combination of nutrient and irrigation management, plant protection and plant spacing. Due to the SCI method, yield in cereal crops have shown average increases of 15-20%; pulses, 20-25%; vegetables, 45-50% and in the case of paddy, yield increases of 25-30% as compared to traditional methods.

Soil Testing & Soil Health Cards:

Soil tests are carried out to check the primary nutrient content like phosphorus, nitrogen and potassium. Also, micro nutrients like sulphur and iron, pH level, electrical conductivity and organic carbon are tested. Optimum quantities of these nutrients need to be maintained for better agricultural production. Soils have often been damaged due to the overuse of chemicals, unpredictable weather conditions like floods, drought etc. and inappropriate cropping and cultivation practices. Hence, on the basis of the information collected through these tests, soil health cards are issued to the farmers that state the results of the tests carried out on their farmland and the kind of crops they are best suited for. Then, our agricultural experts advise them on the best practices to be adopted for improving soil health.

Farmers Field School (FFS):

Open schools in the fields are unique learning initiatives for farmers to enhance, update and share their knowledge with their peers. These are meeting points for farmers to identify problems adversely affecting their crops in actual field conditions and come up with effective solutions. Project team and line department officials advise farmers on-site and encourage them to adopt sustainable agricultural methods that are nature friendly and climate resilient.

Watershed Development:

During the reporting year 2019-20, 263 ha, were treated under this program. The watershed wise achievements in watershed program during the reporting year were as follows:

The numbers of households and hectures have obviously overlapped with many farmers benefiting in more than one program.

BUILDING LIVELIHOODS & EMPOWERING WOMEN:

LAVS is committed to empowering women from marginalized communities to have greater access and control over economic resources and their lives. Our interventions under Mahila Kisan Sashaktikaran Pariyojana (MKSP) and watershed programs are associated with men & women who are engaged in smallholder agriculture and work as farm and nonfarm labour as part of livelihood program. We endeavourer to build capacities and an enabling environment for these men and women to strengthen their resource base, raise their voice and access to a range of rights and entitlements.

Approach:

Tribal and remotely based forest dwelling communities in Odisha face exclusion and multiple vulnerability. This is particularly true for women from marginal communities. Recognizing this reality, livelihood program of LAVS envisages a range of innovative initiatives that help women build a secure and resilient livelihoods and move out of poverty and resource poor



base. The key approaches adopted in livelihood building initiatives include:

- Capacity enhancement
- Asset building
- Collectivization
- Value chain development

As part of enhancing capabilities of smallholder agriculture, our initiatives focused on improving the knowledge, skills and leadership of women from marginalized communities. The theme adopted for building capacities of women and smallholder agriculture during the year included climate resilient agriculture, market engagement, entrepreneurship and business literacy, financial literacy, water harvesting and management.

Farming Communities across the country are struggling to cope and adapt to climate induced shocks. This has been affecting local food production system and increasing food insecurity and desperation amongst agriculture households. Our community based adaptation initiatives through KfW-NABARD supported CCA project seek to train and equip women smallholders and their households for practicing climate resilient agriculture and support development of value chain. Similarly women engaged in small business, access to credit is as important as for business and links to stable markets.

Our livelihood initiatives have integrated Farmer Field School (FFS) as an approach to engage women from marginalized households in exercises where they get to know and test improved ways of practicing agriculture, cooking and improving household nutrition before adopting them. As women manage and lead FFS, SHGs and FPO, it leads to their empowerment both as facilitators and participants providing them, knowledge and skills that can be translated into life-long learning for life situations.

Our Achievements:

- KfW & WDF-NABARD, CCA project implemented in Pottangi block of Koraput district of Odisha led to an increase of average annual farm income from Rs.40,000 to Rs.85,000
- 20 numbers of Zero- Energy- Cool- Chambers (ZECC) constructed during the year have benefited 20 progressive farmers and helped them in reducing post harvest loss and distress sale of vegetables and ensured better market location for higher price.
- Agri-advisory centre at watershed level provided services and inputs to about 128 smallholding women farmers such as soil testing, seed selection, seed treatment appropriate pesticides, herbicides preparation and application etc.
- 158 tribal women and their households were positively impacted through our project initiatives as they were trained on water storage methods and management in their agriculture fields. Community people including



women are now aware of climate hazards and better prepared to cope with climate risks and shocks.

 As part of our effort to promote clean energy option, 114 numbers of improved Cooking Stoves (ICS) have been provided to tribal households to reduce household air pollution and conserve ecology.

TRAINING & CAPACITY ENHANCEMENT:

Consistently and continuously very high priority and focus is given to the training and capacity enhancement to different groups within organization and external groups on different subjects / topics, mainly related with NRM. All our programmes have integral arrangement for the training and capacity building and as a result programmes are well managed with good impact.

Training and capacity building by LAVS is a massive effort, both at the Institute and at village level.

DISASTER PREPAREDNESS & RESPONSE:

Responding to emergencies is a part of LAVS' mandate to rebuild and restore the lives and livelihoods of marginalized communities. Our response teams are well oriented and trained on identifying and reaching out to the most vulnerable and excluded population in our area of presence and providing with them life saving relief aids. Apart from relief assistance, our interventions also spans across disaster preparedness and building resilience of communities and recovery and rehabilitation of disaster survivors.



We prioritize to focus on assisting the most vulnerable like persons with disabilities, elderly with no one to support, pregnant women, widows and lactating mother.

Approach:

At beginning of every emergency situation, our response team informs the affected community members about the purpose and details of assistance program. The team members are introduced to the community so that people can approach them freely whenever required. Orientation of local volunteers is taken before they are deployed for assessment and assistance.

Assessment with participation from communities is conducted to identify the most affected villages households in village. While selecting beneficiaries, it is ensured that excluded households get identified.

Our Achievements:

- 22 local volunteers from 6 Grampanchayats of Pottangi block, Koraput district oriented and trained on sanitation, social distancing and mask use as part of COVID-19 emergency preparedness & response.
- 6 Volunteers attended training at district level and were issued pass from district administration to work locally for community sensitization and distributed 500 masks among the farmers going to sell produce in local hats.
- Conducted awareness campaigns on COVID-19 in 24 villages.
- Facilitated distribution of PDS ration ensuring social distancing in 5 GPs.

Watershed Development

Integrated Watershed Development for Rehabilitation of Degraded Soil and Climate Change Adaptation

Post watershed intervention, LAVS is implementing the project to introduce climate resilient agricultural practices in Turia Watershed Cluster, Pottangi block of Koraput district. The project is supported by the NABARD, Odisha RO with funding from KfW, Germany.

Key Activities undertaken under the initiative:

- Capacity building of Community Based Organizations to address their needs to augment incomes/ farm productivity and mitigate climate impacts on agriculture
- Creation of irrigation potential
- Land treatment and water management
- Adopting soil and water conservation measures
- Promotion of organic farming
- Adaptation of technology to mitigate climate change impact
- Promoting agro-forestry
- Ensuring diversity in ecological goods and services
- Giving exposure to farming communities
- Training and knowledge transfer

Promotion of Millet

The program was launched in 2017-18 in 11 districts of the state of Odisha. LAVS covers Pottangi block of Koraput district under 'Special Program for Promotion of Millets in Tribal Areas' since 2017 in Mission mode. The program uses advanced technologies such as Line sowing and transplantation, seed and root intensification etc. The basic objective of the intervention is to increase millet



production and prove market linkage to the producers and promote millet based food

RURAL CONNECTIVITY AND COMMUNICATION


Prime Minister Gram Sadak Yojana (PMGSY) is implemented by the Ministry of Rural Development, Govt. of India. Intending to connect all habitations; having more than 500 population in plains and 250 in hilly areas, the programme all areas in the country. LAVS is engaged as the Project Implementation Consultant (PIC) for the state of Odisha since 2012 by the Odisha State Rural Roads Authority (OSRRA). The program is supported by the Asian Development Bank's credit assistance.

In accordance with the policy guidelines of ADB, the implementation requires to adhere to certain principles; ensuring social safeguard instruments, ensuring addressing environmental issues emerging out of road construction, ensuring maintenance and road safety measures etc. It is the prime responsibility of the PIC to prepare certain documents basing of the guidelines/ formats on these themes.

Social Safeguard Documents: Basing on the Community Participation Framework (CPF), LAVS conducts transect Walks across the proposed alignment, conducts Palli Sabhas where the voices of the communities are heard, suggestions are recorded etc. Issues relating to the proposed construction, marking of the alignment, loss of private land, structures, assets, utilities and common property resources are discussed and reached a conclusion. Things are materialized in presence of the PRI members, line department officers, revenue department officers etc.



Conducting Road Safety Awareness: People tend to become careless while driving in a developed road and usually meet with accidents. In this consideration, the implementation of construction of PMCSY roads, it is mandated to create awareness on road safety among the community with special reference to the road users. The PIC-LAVs is responsible for creating road safety awareness by conducting awareness camps etc. As most of the schools in rural areas are located adjacent to the alignments, the school students are also taken as primary target groups of such interventions.







this, the PIC-LAVS conducts Awareness Camps on HIV/AIDS targeting the workforce and the community in general.

Training of Field Engineers: A training programme for Field Engineers such as the Asst. Engineers, Asst. Executive Engineers and Junior Engineers was conducted at RCTRC, Bhubaneswar. The programme was of 6-day duration, commencing from 27/01/2020. It was participated by 194 FEs from 60 R W Divisions across the state. Out of the participants, 7 were females.

Social Impact Assessment Study

The State SIA Unit, the Nabakrushna Choudhury Centre for Development Studies (NCDS) assigned one Social Impact Assessment Study to LAVS to be carried out in the villages Balabhadrapur and Kaliapal for improvement of Rangadihi-Fuljhar-Balabhadrapur-Jagdala Dam Road from 18.0 KM to 28.0 KM in Keonjhar district. LAVS carried out the study in accordance with the standard measures taken for such studies. The study was completed with two months commencing 15th March 2019.



The survey included collection of household data; preparation reports basing on the data collected and conduct Public Hearing. Public hearing was conducted between the time of approval of Draft Report and submission of the Final Report. The survey covered 1659 persons living in 348 households.

ADDRESSING HEALTH WATER AND SANITATION

LAVS is envisaging the promotion of health of the community through Drinking Water and Sanitation Programme. By designing targeted interventions to promote full sanitation

coverage in the villages, the community witnesses positive cultural drive including behavioral changes. Sensitizing community on the importance of Health and Sanitation through awareness programs on transmission of water borne diseases, ill-effects of open defecation and enabling them to identify effective risk management practices through initiatives such as Health Camps, Nutrition Programmes, Health Insurance Coverage, Drinking Water Supply systems, Toilet Construction and promotion of Improved Cooking Stoves is the major leap towards clean and safe environment. Lack of safe water supply, poor environmental sanitation, improper disposal of human excreta, and poor personal hygiene help to perpetuate and spread diseases in the villages which requires a community-based management approach.

An integrated approach to water quality assessment and management from source to consumer is ensured through community piped water supplies. Assessing the quality of drinking water in villages and ensuring availability of safe drinking water is done through Gravity flow based systems in reliable drinking water sources. This prevents water contamination through proactive and participatory approach of local institutions collaborating with external organizations. Village Institutions organized by LAVS anchors the implementation of Sanitation Programme by joining hands with the Gram Panchayat and leveraging Government schemes for Individual Household Latrine (IHHL) construction. This encourages behavioral change in the community with focus towards women health and hygiene.
